The Rockcastle County real property tax roll will be opened for inspection from May I through May 15, 2000. Under the supervision of the property valuation administrator or one of the deputies, any person may inspect the tax roll.

This is the January 1, 2000 assessment on which state, county and school taxes for 2000 will be due about September 15, 2000.

Any taxpayer desiring to appeal an assessment on real property made by the PVA must first required with the PVA or a designated deputy. The conference may be held prior to or during the inspection is Any taxpayer still aggrieved by an assessment on real property, after the conference with the PVA or design deputy, may appeal to the county board of assessment appeals.

The taxpayer can appeal his assessment by filing in person or sending a letter of other written petition stating the reasons for appeal, identifying the property and stating the taxpayer's opinion of the fair cash value of the property.

The appeal must be filed with the county clerk's office no later than one work day following the conclusion of the inspection period.

Any taxpayer failing to appeal to the county board of assessment appeals, or failing to appear before the board, either in person or by designated representative, will not be eligible to appeal directly to the Kentucky Board of Tax

Appeals of personal property assessments shall not be made to the county board of assessment appeals. Personal property taxpayers shall be served notice under the provisions of KRS 132,450(4) and shall have the protest and appeals rights granted under the provisions of KRS 131,110.
